

# PERCEPTION OF THE KNOWLEDGE OF DENTISTRY UNDEGRADUATES ABOUT OROFACIAL HARMONIZATION

### INTRODUCTION

The relationship between oral and facial aesthetics is notorious in society and the search for aesthetic procedures calls for the specialty of Orofacial Harmonization (HOF).

The objective of this work is to evaluate the knowledge of students of the Faculty of Dentistry - Federal University of Rio de Janeiro (FO-UFRJ) about procedures and the legal aspects of the specialty, because of the growing number of dentists who wish to work in this area.

## METHODS & MATERIAL

An evaluation was carried out using an electronic questionnaire on the Google Forms Platform, addressing general and specific aspects of orofacial harmonization. The students were invited to participate on a completely voluntary basis in the period of 2 months from March to April 2023, totaling 159 answers. The collected data were tabulated in Google Forms itself, where we made a descriptive and statistical analyzes were performed.

- The inclusion criteria were students from the 1st to the 8th period at FO-UFRJ, adults and without gender restriction, with active enrollment during the completion of the questionnaire.
- The exclusion criteria are all who are not FO-UFRJ students, all with enrollment suspension; in the process of retirement; graduate students.

#### RESULTS

P7	Is liposuction of the chin with deoxycholic acid allowed at the CD?
P8	Is the facelift technique with orofacial threads allowed by the dentist?
P9	Is microneedling a procedure allowed by a dentist?
P10	In case of complications during or after HOF procedures, the dentist (CD) is allowed to prescribe antibiotics?




Chart 4 - Result of the answers of the students who answered from 7th to 8th period.

#### CONCLUSION

According to the results obtained in the analysis:

- 1. As for the students' knowledge about the procedures integrated in the HOF, there was a lack of certainty in relation to the field of action of the specialty;
  - 2. We identified the need to include HOF teaching in the undergraduate curriculum.
  - 3. The main lack of knowledge of the study participants was related to Rhinoplasty procedures.
- 4. The main means of information for students is still social media, which makes it essential for the University to occupy this space, avoiding the dissemination of wrong or misleading information on the subject.
