



Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. <u>Insurance Coverage is not optional.</u>

This insurance must be in force during the lease dates of the event, November 29-December 5, 2025, naming Greater New York Dental (200 W. 41 Street – Suite 1101 New York City, NY 10036) as the certificate holder. The following must be named as additional insured: Greater New York Dental Meeting Organization Committee, The New York Convention Center Development Corporation, The Empire State Development Corporation, Tri-Borough and Tunnel Authority the Security Contractor; JKJCC Security, the Official Full-service Contractor and Freeman.

Rainprotection Insurance Program
